

LETTER OF AGREEMENT ESTABLISHING CAMP USE

_____ agrees to provide the South Texas Council, Boy Scouts of America, with the required documents listed below at least a week prior to event.

A certificate of liability insurance with a minimum of \$2,000,000, combined single limit with the South Texas Council, Boy Scouts of America, and the National Council, Boy Scouts of America, named as additional insured, ten (10) day written notice of cancellation, and the period of time involved.

A Hold Harmless Agreement. (copy attached)

A certificate showing non-profit and/or tax exempt status

A roster showing the names of all youth and adults participating in this activity.

It is understood and agreed to by both parties that the fee for use of CAMP KARANKAWA'S _____ facilities and is required to be paid at the Council Office prior to arrival at camp.

It is understood and agreed to by both parties that _____ shall be responsible for any and all damages to camp property which may reasonably be attributed to the actions of the said group agrees to promptly pay any and all reasonable damage claims when presented.

It is understood and agreed by both parties that no alcoholic beverages, illegal drugs, fireworks, or chain saws of any kind are permitted or to be used on the premises.

It is understood and agreed by both parties that _____ will provide at least one adult leader (defined as 21 years of age or older for purpose herein) for every ten (10) members of the party present in camp below the age of 21 years, that at least one of the said adult leaders must be present with the group at all times while the group is in camp. Co-ed groups must provide a male and female adult as defined above, based on the ratio of one adult for every ten (10) members below 21 years of age.

It is understood and agreed to by both parties that the group will abide by any and all of the camp operating rules and directions of the Camp Ranger and/or Campmaster.

It is further understood and agreed to by both parties that should the group fail to provide proper leadership or fail to abide by camp rules or directions of the Camp Ranger and/or Campmaster of the South Texas Council, he may in his/their discretion, terminate this agreement and require the renting parties to vacate the camp, forfeiting any and all fees and monies agreed to herein.
