



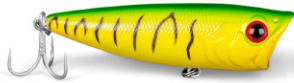

## 2024 Official Rules (page 1 of 2)

The following are the Official Rules for the 2024 South Texas Council Boy Scouts of America Fishing Tournament. It is the contestants' responsibility to read, understand, and comply with all of the rules outlined below. Non-compliance will be grounds for disqualification from the tournament. By registering for and participating in the South Texas Council Boy Scouts of America Fishing Tournament, each team and participant agrees to be bound by these Official Rules.

- 1.** Teams must be pre-registered to participate, and no registration will be allowed after the deadline unless extended in writing by tournament director. Entry forms must be received by 5:00 pm by email (soneal@fultonconst.com or martin.sepuleda@scouting.org) by the stated entry deadline (June 1, 2024) to participate. Entry forms must be complete with all names and contact information. Tournament will be held rain or shine - no refunds. Payment shall be made out to "South Texas Council, BSA" and mailed to South Texas Council, BSA, 700 Everhart Road, Building A, Corpus Christi, TX 78411.
- 2.** This is a team tournament. Each team shall consist of no more than four anglers. A team entry can consist of one or two or three anglers but will compete against all the other full teams. Guides, amateurs, general public, and anglers of all ages welcome to enter as a four-person team; each team should try to include at least one registered youth Scout member. Team(s) may hire a guide if they so choose, but guide-caught fish cannot be entered in competition unless the guide is a named member of the team.
- 3.** Tournament goodie bags including fishing towel, raffle tickets, meal tickets, event hat, etc. will be distributed at the Friday night social or the Saturday weigh-in to the Captain or first team member to check in. Bags must be picked up at the events. We will not distribute after the event unless by written arrangement with the tournament director.
- 4.** Entrants must be present to win in the raffle or door prize giveaways.
- 5.** Fishing is allowed only in Texas State waters. Anglers may fish in any way they choose by boat, wade, surf, pier, jetty, beachfront, etc. Fish must be caught on rod and reel with live, dead, or artificial baits.
- 6.** Tournament Fishing Times are 6am to 2pm June 8, 2024. No captain's meeting or check-in required prior to fishing. Only fish caught during tournament fishing times may be entered in the competition. The fish weigh-in location is downstairs at Doc's Seafood & Steaks under the JFK causeway on the Intracoastal Waterway on North Padre Island, Corpus Christi. Weigh-in will open at 12pm and close at 2pm. Each team must present their fish to be weighed for competition between 12pm and 2pm or be standing in line with their fish at 2pm to qualify for tournament prizes. The last person in the weigh in line at 2pm will be identified according to the tournament director's watch and no subsequent fish may be weighed or entered.
- 7.** All state and federal laws must be observed. Fish must be of legal size according to Texas Parks & Wildlife Department regulations. No angler may retain a trout over 20", and each team shall not weigh more than one trout for the competition (same trout to be considered for biggest trout and for heaviest stringer categories)." No oversized/tagged redfish may be entered in the tournament, competition is only for slot redfish. No oversize drum. No oversize trout. Slot sizes are as follow red drum 20-28", all trout 15-20", black drum 14" -30".

## 2024 Official Rules *(page 2 of 2)*

- 8.** The winning fish in weight categories will be the heaviest fish by weight in pounds as determined by the tournament weighmaster. In the event of a tie by weight, the winner will be the fish with the longest overall length, weight, and girth. In the event there is still a tie, the winner will be the fish that was weighed in first.
- 9.** Team prizes: The heaviest slot redfish will be awarded tournament prizes as follows (first place \$300, second place \$200, third place \$100). The heaviest speckled trout will be awarded tournament prizes as follows (first place \$300, second place \$200, third place \$100). The heaviest Other will be awarded as follows (\$150 first place only).
- 10.** The tournament weighmaster will be an experienced fish handler to measure and weigh fish. If, in his/her opinion, any fish entered in the tournament was caught outside tournament fishing times or was caught by means other than rod and reel or was tampered with in order to alter weight or length, the team entering the fish in question is subject to disqualification at the discretion of the tournament director. All decisions by the weighmaster and tournament director are final.
- 11.** All protests, objections, or suspicions of violations of Official Rules must be provided to the tournament director in writing prior to announcement of the winners. Failure to provide timely written notification will be grounds for dismissal of the objection.
- 12.** No outside alcohol, food or insulated cups are allowed inside the venue (Doc's Seafood and Steaks).
- 13. HOLD HARMLESS AND INDEMNITY AGREEMENT: Each angler, for himself/herself, and for minor children in their custody or control (hereafter jointly "Participant"), hereby releases and discharges the South Texas Council Boy Scouts of America, its employees, directors, volunteers, and officers (hereafter jointly South Texas Council) from any claims, damages, injuries, actions or suits arising in any way from Participant's participation in the tournament, and agrees to indemnify the South Texas Council from such, EVEN IF THE CLAIMS, DAMAGES, INJURIES, ACTIONS OR SUITS ARE DUE TO THE SOLE FAULT OR NEGLIGENCE OF THE SOUTH TEXAS COUNCIL.**
